## <u>Precaution Measures and Guidelines for attending the 2022 General Meeting of Shareholders,</u> <u>regarding the outbreak of Coronavirus-2019 (COVID-19)</u>

1. The Company asks for the Shareholders' kind cooperation to appoint the independent director as your proxies (The details of Independent Director in attachment 5), please complete your details and sign the Proxy Form attached herewith or may be downloaded from website (requested voting in each agenda in advance). Shareholders are welcome to submit the proxy form to the Company at least 3 working days prior the meeting, addressed to:

- 2. The venue will be cleaned prior to the meeting.
- 3. Attendees will be assigned to a seat with appropriate social distancing at the minimum of 1.5 meters from each other. The Company arranges seating 50 seats for shareholders and/or proxies, each attendee will be assigned a seating number and required to sit as specified for the sake of the disease prevention or following up in case of any unforeseen circumstances.

If all the seats have been reserved, shareholders and/or proxies can still appoint one of the Company's independent directors as a proxy to vote on your behalf.

- 4. The Company has issued the meeting protocols for attending the General Meeting of Shareholders with the concern on the COVID-19 as follows:
  - 4.1 All attendees must keep a face mask and must fill out the COVID-19 screening form. If attendees including those closely who have history of traveling to the high-risk countries of COVID-19 infection as announced by the Ministry of Public Health or any individual showing symptoms of fever, cough, and runny nose will not be allowed entering the meeting.
